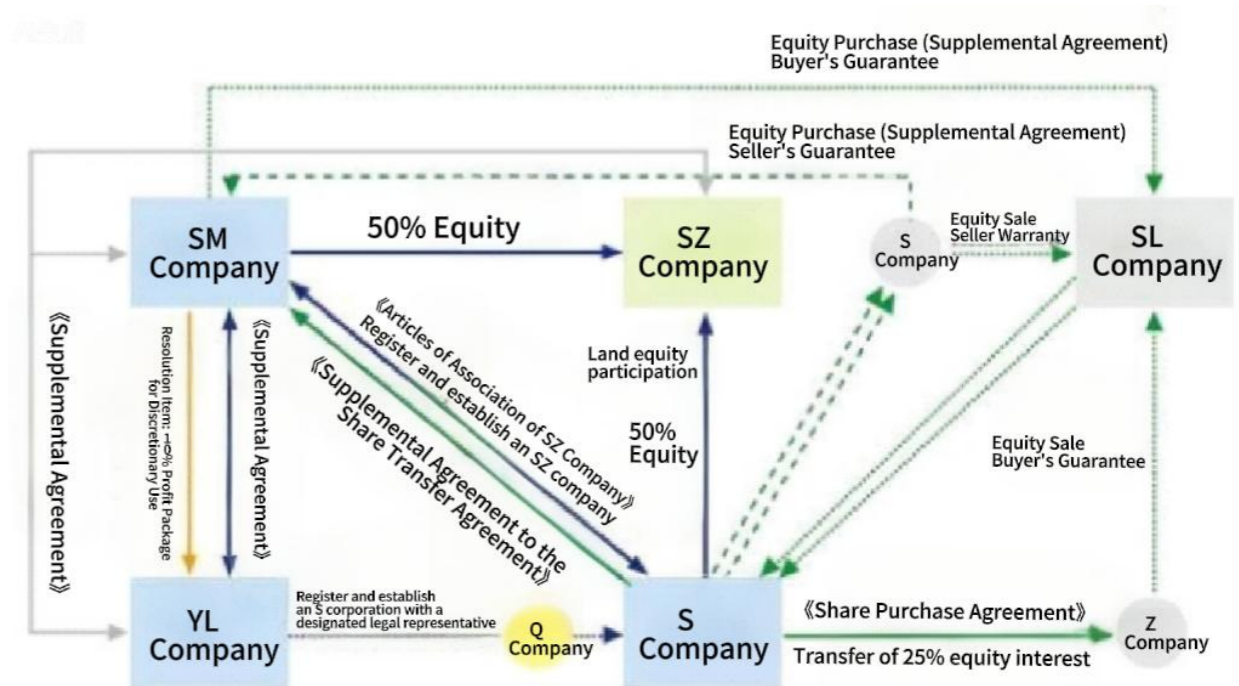
PROCESS ORIENTED LITIGATION

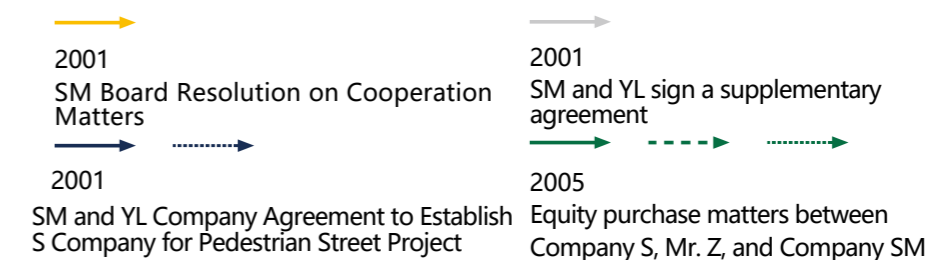


CASE VISUALIZATION

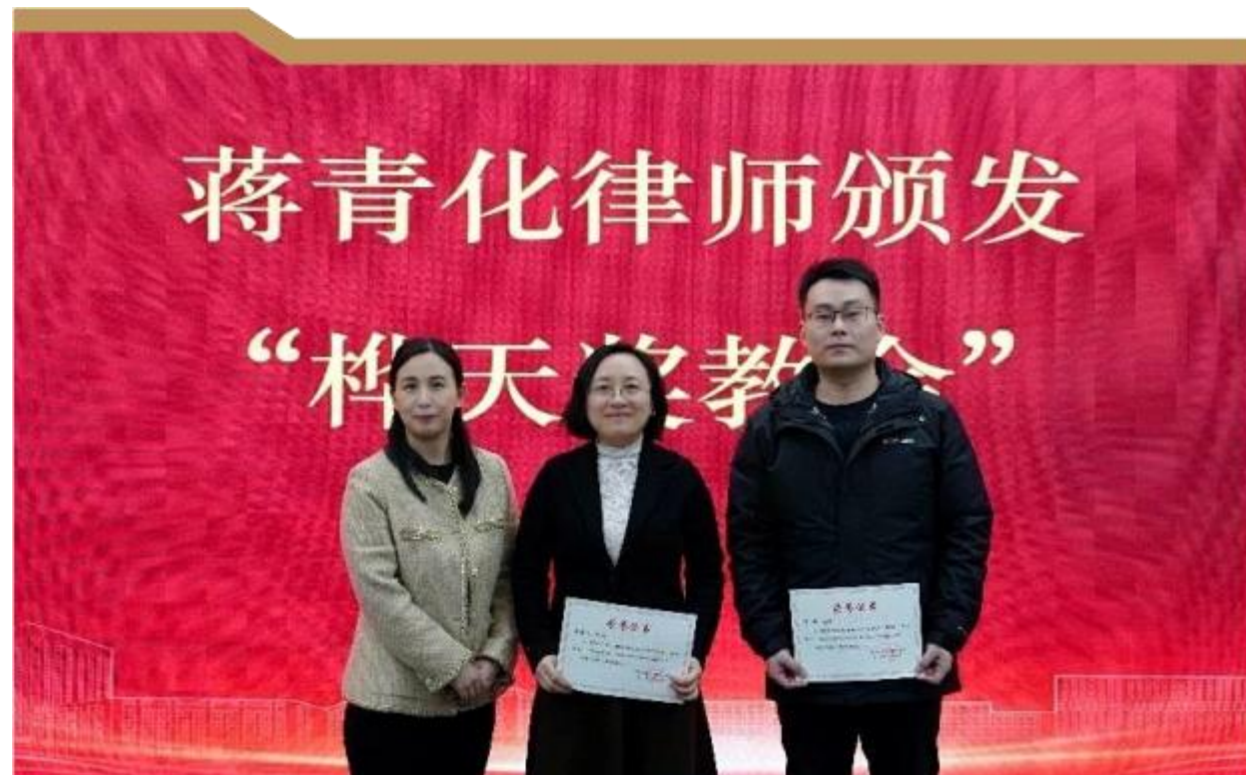
HUATIAN SCHOLARSHIP
